1. Executive Summary

ZPZ is the utility token of the ZPZ Trading ecosystem, created to empower retail traders with advanced AI-Powered utilities, analytics, governance, staking, and community-driven growth. Built on Polygon (POL), ZPZ provides token-gated access, DAO participation, and adoption incentives. Fixed, non- inflationary supply with 50% long-term locked float.

2. Vision & Mission

Vision:

To redefine trading by powering a unified, data-driven ecosystem where every transaction, reward, and strategy is fueled by ZPZ Coin, enabling smarter trading, portfolio management, Al-driven insights, staking rewards, governance voting, and token-gated access to advanced analytics.

Mission:

To integrate blockchain utility with real-time market intelligence, creating a smarter, fairer, and reward-based trading experience for everyone through access control, premium AI tools, community incentives, copy trading, and marketplace transactions.

3. ZPZ Utilities


- Staking Rewards: $17\% \rightarrow 9\% \rightarrow 4\%$ (fixed pool).
- Governance: Proposals & votes on priorities, treasury, listings.
- Premium Access: Indicators, mentorship, elite tiers.
- Payments: Alerts, mentorships, subscriptions, Al tools.
- NFT & Reputation: Badges and milestone NFTs.
- Community Incentives: Referrals and ambassador programs.
- Data Access: Token-gated feeds.
- Treasury & Development: Ops, listings, integrations.

4. Tokenomics

Token: ZPZ (ERC-20, Polygon), 18 decimals. Total supply: 20,000,000,000 ZPZ (fixed). Third-Party Locked Float: 50% (10B) in escrow; unlocks begin Year 5 at 10% of locked float per year.

5. Presale & Distribution

- Private Team Allocation Presale: 10% @ \$0.001 (completed).
- Public Presale: Oct 1 Dec 31, 2025 1B @ \$0.005.
- DEX Launch: Jan 10, 2026 at \$0.01 (Polygon).
- Target CEXs: Q2 2026 (KuCoin, Gate.io, MEXC, OKX, BitMart); larger venues to follow.
- Purchase Limits: Standard \$10k; Lifetime \$15k.
- Finality: All sales are final; trading begins on exchanges.

6. Roadmap

- Q4 2025: Public presale.
- Q1 2026: DEX launch & token lists.
- Q2 2026: Initial CEX listings.
- 2026–2027: NFT/reputation, data integrations, mentorship.
- Post-Vesting (Year 5+): Expanded DAO & staking; grants.
- Long Term: Cross-chain expansion and partnerships.

7. DAO Governance (Summary)

- Model: Snapshot voting (1 ZPZ = 1 vote) with delegation; on-chain execution via timelock and Gnosis Safe.
- Scope: Features/partnerships; treasury & grants; parameter updates; upgrades/deployments.
- Process: Forum review (3 days) → Snapshot vote (5 days) → Timelock (72h) → Execution;
 calldata and tx hashes are published.
- Thresholds: Proposal threshold 0.10% of circulating ZPZ; quorum 5% (8% for major actions); simple majority to pass.
- Treasury: 4/7 multisig. Tiers T1 ≤\$25k (council, \$100k/mo cap), T2 \$25k-\$250k (DAO vote), T3 >\$250k (higher quorum & timelock).
- Safeguards: Emergency pause (7 days, report in 24h), audits & bug bounties, quarterly reports, signer rotation policy.
- Decentralization: Guardian powers sunset after 12 months or earlier by DAO vote.

8. Security & Audit

- Auditor: OpenZeppelin (planned); reports published.
- Controls: Reentrancy guards, role-based access, pausable modules, MEV/sniping mitigations.
- Key Management: Multisig custody; separation of duties.
- Bug Bounty: Public program with tiers.
- Audit Timeline: Internal checks pre-presale; external audit pre-DEX; audits on major upgrades.

9. Legal & Compliance

- Utility token; not equity; no profit promises.
- Regional restrictions may apply; comply with local laws.
- All sales final; market pricing determined post-launch.
- KYC/AML requirements for large purchases will be published before presale.
- ZPZ branding & ticker: trademark pending.

- Slogan: Al-Powered Smarter Trading Coin.
- Brand kit to be published prior to launch.
